## USE TAX INSTRUCTIONS

- The Use Tax Return is to be filed by persons, firms or corporations storing, using or otherwise consuming tangible personal property in the City of Tuscaloosa or its Police Jurisdiction. Use tax is imposed on the sales price of the property only if City of Tuscaloosa sales tax cannot be assessed. (*City of Tuscaloosa Use Tax Ordinance 3313, adopted November 1, 1991, as amended, City of Tuscaloosa Code §7-44*).
- Explanation of Various Rates:
  - General Merchandise Rate of .02 (2%) is used to report all other purchases of tangible personal property purchased for storage, use or consumption in this city.
  - Vehicle/Machine/Manufacturing Rate of .0075 (3/4 of 1%) is used to report total purchases of new and used automobile vehicles, truck trailers, semi-trailers, farm machinery and equipment, and total purchases of machines and replacement parts used in manufacturing, processing, compounding, mining, and quarrying.
  - Police Jurisdiction rate is ½ of City rate.
- Use Tax return is to be filed with the City on a monthly basis. Pursuant to the Local Tax Simplification Act of 1998, businesses whose state sales tax liability averages less than \$200 per month during the preceding calendar year may file use tax on a quarterly basis with the City of Tuscaloosa if a written request for such filing is received and approved by the City of Tuscaloosa Revenue Department.
- To avoid the application of penalty and/or interest amounts, this report must be filed on or before the 20th of the month following the period for which the report was submitted. Cancellation postmark will determine timely filing.
- A remittance for the total amount due made payable to the taxing jurisdiction must be submitted with this report.
- Any credit for prior overpayment must be approved in advance by the taxing jurisdiction.
- No duplicate or replicated forms acceptable except with prior approval of the taxing jurisdiction.
