AMENDMENT #26 TO THE CITY OF TUSCALOOSA'S 2013 COMMUNITY DEVELOPMENT BLOCK GRANT FOR DISASTER RECOVERY ACTION PLAN

The City of Tuscaloosa desires to make the following non-substantial amendments to the 2013 Community Development Block Grant for Disaster Recovery (CDBG-DR) Action Plan that was previously approved by the U.S. Department of Housing and Urban Development (HUD). The amendment to the Action Plan to facilitate recovery with the creation of a new activity and reallocation of funds from completed activities. With the amendment to the Action Plan, \$43,932,000.00 in projects will be funded.

The following amendments shall be made:

1. Reallocate \$10,420.34 from Street Reconstruction Phase II – 15th Avenue and 9th Street East Round 9 extended and create a new activity known as 10th Avenue Round 9 extended
2. Reallocate \$4,349.23 from Alberta Park Round 11 extended to 10th Avenue Round 11 extended
3. Reallocate \$31,620.46 from Alberta Technology Library Round 11 extended to 10th Avenue Round 11 extended
4. Reallocate \$243.45 from PARA Park Improvements - Jaycee Round 11 extended to 10th Avenue Round 11 extended
5. Reallocate \$1,036.75 from PARA Park Improvements – Harmon Round 11 extended to 10th Avenue Round 11 extended
6. Reallocate \$21,803.93 from Technology Infrastructure Round 11 extended to 10th Avenue Round 11 extended
7. Reallocate \$28.80 from Street Reconstruction Phase II - 20th Street East Round 11 to 10th Avenue Round 11 extended
8. Reallocate \$41,846.70 from Street Reconstruction Phase II – 21st Avenue East Round 11 extended to 10th Avenue Round 11 extended
9. Reallocate \$8,650.34 from Street Reconstruction Phase II – 22nd Avenue East Round 11 extended to 10th Avenue Round 11 extended
