Sealed bids will be received by the Director of Transportation at the office of the Alabama Department of Transportation, Montgomery, Alabama until 10:00 AM on December 01, 2017 and at that time publicly opened for constructing the Roadway Improvements on Hargrove Road from the intersection of 10th Avenue to the junction of Hackberry Lane in Tuscaloosa. Length 0.450 mi.

The total amount of uncompleted work under contract to a contractor must not exceed the amount of his or her qualification certificate.

The Entire Project Shall Be Completed In One Hundred Fifty (150) Working Days.

A 7% DBE Contract Obligation Is Required

A Bidding Proposal may be purchased for \$5.00. Plans may be purchased for \$23.00 per set. Minimum wage rates for

this project have been pre-determined by the Secretary of Labor and are set forth in the advertised specifications. This project is subject to the contract work hours and Safety Standards Act and its implementing regulations.

Cashier's check or bid bond for 5% of bid (maximum - \$50,000.00) made payable to the Alabama Department of Transportation must accompany each bid as evidence of good faith.

The bracket range is shown only to provide general financial information to contractors and bonding companies concerning the project's complexity and size. This Bracket should not be used in preparing a bid, nor will this bracket have any bearing on the decision to award this contract.

The Bracket Estimate On This Project Is From \$1,786,747 To \$2,183,802.

The proposed work shall be performed in conformity with the rules and regulations for carrying out the Federal Highway Act.
